### 5. TRANSPORTATION ACTION/DISCUSSION ITEMS

A. MCTC Policy Board Support of the California Inland Port Project and a Grant Application for Port and Freight Infrastructure Program Funding

The following public comments on this item were made by Madeline Harris, Policy Advocate, Leadership Counsel for Justice and Accountability:



- The MCTC Board should not support the Inland Port System currently nor support the submittal of a grant application.
- The vision of the Inland Port System is not realistically able to meet its objectives of reducing emissions created in the goods movement process by transitioning more goods movement to rail and away from heavy trucks.
- Inland Port System sites may potentially be located near already burdened communities who may suffer negative side effects because of truck travel associated with the project.
- The Inland Port System project should not move forward unless environmental justice consideration are addressed.
- The process to develop the Inland Port System is not transparent and there has been no meaningful community engagement or engagement with community-based organizations.

The following public comments were received by Madeline Harris, Policy Advocate, Leadership Counsel for Justice and Accountability:

- Requested county staff to specify projects funded by SB1 funds in Fairmead.
- Recommends Measure T to fund street lighting in Fairmead and LaVina.
- Recommends that an equity component be introduced into how the County prioritizes transportation projects in its pavement management system.
- Recommends safe routes to school funding to be prioritized at Sierra Vista Elementary to improve the school drop-off system for children (Ellen Bitter and Commissioner Gallegos provided a response).



• Requested MCTC staff to review prior unmet transit needs comments received from the Leadership Counsel.

B. Measure T Election Results – November 8, 2022

The following public comments were received by Madeline Harris, Policy Advocate, Leadership Counsel for Justice and Accountability:

- Provided opinion and perspective on why Measure T failed: community wasn't meaningfully
  engaged; residents and community organizations' feedback were not addressed; and the
  Investment Plan was not what the voters wanted.
- Recommended a community-wide discussion on Measure T through an in-person public forum if/when moving forward with a renewal measure and hire a new pro-facilitator that can conduct meaningful community engagement.
- The Leadership Counsel should not be characterized as opposition any longer and recognizes Measure T is a super important funding source to get projects done. Expressed interest in working together to create a community driven transportation future.
